The Governing Body of the Samiti shall have powers to make by laws, in so far as they are not repugnant to the rules and regulations for the time being in force, shall have the same force and vailidity as the Rules and Regulations of the Samiti.

# EXTRA ORDINARYMEETINGS.

Extra Ordinary General Meeting of the Samiti may be held as and when necessary or on the requisation of five members of the Samiti.

### MEETINGS OF THE GOVERNING BODY 12.

Meetings of the Governing Body of the Samiti may be held as and when necessary or on the requisitation of three members of the Governing Body.

#### TIME AND PLACE OF MEETING :-13.

The time and place of the Annual and Extra-ordinary General Meetings of the Samiti and all Meetings of the Governing Body shall be fixed by the Secretary unless the Governing Body in any case decides otherwise.

#### REQUISITIONS BY THE MEMBERS. 14.

All the requisitions by the members for the meeting of the Samiti or of the Governing Body shall be in writing, signed by the requisitionists and shall contain the If the Secretary fails objects of the proposed meeting. to call a meeting within one month from the date of the receipt of the requisition, the requisitionists will be entitled to a meeting at the Head Office of the Samiti within two months from the date of the receipt of requisition by the Secretary. Any meeting called under this provision shall be called in the same manner as nearly as possible as that in which other meeting are called by the Secretary.

Unless specially provided for by the satute or the Rules and Regulations of the Samiti, all matters 15. comming before the Samiti shall be decided by a majority of votes. In case of equality of votes, The Secretary will have the casting vots.

- The funds of the samiti may be deposited in such Bank, or Banks or invested in such manner as may be decided from time to time by the Governing Body.
- All property movable or immovable, belonging to the Samiti shall vest in the Governing Body for the time being of the Samiti. All deeds and documents on behalf of the Samiti may be executed or be got executed by the Secretary or such other person as executed by the Secretary or such other person as may be authorised for the purpose by the Governing Body.
- 18. The Secretary shall be compentant to sue or be sued on behalf of the Samiti.
- The Samiti and the Governing Body shall have power to act and be deemed to be duly constituted not with standing any vacancy in their membership.
- 20. The Samiti may alter or add to any of its Rules and Regulations by the majority of three-fifths of the members present at the meeting such majority not being less than half of all the members of the Samiti. Decesion on any matter which the Secretary considers urgent may be taken by the circulars to the members, where at least half the number of members has given assent and provided that there is no dissentient opinion from any member.
  - The Secretary and may delegate to the Assistant Secretary and may delegate to the Assistant Secretary all such power for the management of the affairs of the Samiti as he considers necessary. (Resolution passed in Meeting of M.S.S. on 1-11-1968.)
